HIS HON SIR HOWARD MORRISON, QC served as a judge of the International Criminal Court appeals chamber from 2015 to 2021 completing two terms as President of the Appeals Division. Prior judicial appointments included the Special Tribunal for Lebanon, a UK Circuit Judge, Senior Judge of the Sovereign Base Areas of Cyprus, Chief Magistrate of Fiji and Senior Magistrate of Tuvalu. He is a Fellow of McLaughlin College of York University, a Senior Fellow of the Lauterpacht Centre for International Law at Cambridge University, an Hon Professor of Law at both Warwick and Leicester Universities and a visiting Professor of Law at Northumbria University. He is a Fellow of the Royal Geographical Society and a Fellow of the Royal Society of Arts and a Patron of REDRESS. He was appointed, in turn, OBE (1988) CBE (2007) and was knighted by Her Majesty Queen Elizabeth (KCMG) in 2016 for services to international law and the rule of law.

ELIES VAN SLIEDREGT is a Professor of Criminal Law & Procedure at Tilburg University, The Netherlands. Previously she was professor of law at the University of Leeds and Director of its Centre for Criminal Justice Studies (CCJS). Before that, she was professor of criminal law at the Vrije Universiteit Amsterdam and Dean of the Faculty of Law from 2011 to 2015. In 2010, she was visiting professional with Chambers at the International Criminal Court. She was the 2015 Holding Redlich fellow at the Castan Center for Human Rights at Monash University, Melbourne and was appointed Fellow of McLaughlin College, York University, Toronto in 2018. Elies is senior editor of the Leiden Journal of International Law, a member of the Royal Holland Society of Sciences and Humanities and a Trustee of the British Institute of International and Comparative Law (BIICL). She has published extensively in the field of international, European and comparative criminal law.

DR. JAMES C. SIMEON is the Head of McLaughlin College and an Associate Professor in the School of Public Policy and Administration. His area of research is primarily in international law and, especially, international refugee law. He has published widely in this area of international law and in public policy and administration.

JUSTICE BOSTJAN ZALAR is a Senior High Court Judge, Administrative Court of the Republic of Slovenia (2004 →), President of the IARMJ-Europe (2018 →), Ad hoc Judge of the European Court of Human Rights (2010 →), Member of the Editorial Team based on the contract between European Union Asylum Agency (EUAA) and IARMJ-Europe on development of the core judicial training materials for judges in the field of Common European Asylum System (2015-2022), Member of the (EUAA) Network of Courts and Tribunals (2011 → Member of the Pool of Experts in the Field of Legal Migration Expert (EU Commission, 2019 →), Professor at the University of Ljubljana (2007 →), Lecturer at the Legal Clinics on Refugee Law, Faculty of Law, University of Ljubljana (2001→), Elected member (2012-2019) of the Council of the European Law Institute (Vienna) and coordinator of the project: "Detention of Asylum Seekers and Irregular Migrants and the Rule of Law" (2017),

HILKKA BECKER is the Chairperson of the International Protection Appeals Tribunal (Ireland) since April 2017. She was previously a Deputy Chairperson of the Tribunal and served as a part-time Member of the Refugee Appeals Tribunal from 2013 to 2016. Over the course of her career to date, she was Senior Solicitor at the Immigrant Council of Ireland – Independent Law Centre, for over 10 years, Regional Legal Advisor and consultant with the International Organization for Migration (IOM), solicitor in private practice and Legal Officer with the Irish Refugee Council.
